

INDIVIDUAL STUDENT ENROLLMENT AGREEMENT

The Individual Student Enrollment Agreement is an addendum to and is hereby made part of the Site-Based Academic Services Agreement dated <u>August 15, 2022</u> between Wesley Family Services and CHARTIERS VALLEY SCHOOL DISTRICT.

The school district agrees to enroll in Wesley K8 School or Wesley High School a program of Wesley Family Services for the Academic Year 2024-2025.

Tuition for Full-time enrollment per semester:

First Semester: \$18,000 Second Semester: \$18,000

Refund Policy:

If a student withdraws or is dismissed during the first 30 calendar days of enrollment, a credit of 75% of that semester's tuition will be issued. If a student withdraws or is dismissed after 30 days of enrollment, no credit or refund will be issued. The party or parties contracting with the Wesley Private Academic School will be responsible for any portion of the tuition remaining unpaid at the time of withdrawal or dismissal, less any credit due.

Matriculation Fee:

A one- time Matriculation Fee of \$200.00 is charged for new students. This amount is in addition to the annual tuition fee and is non-refundable.
