On Tuesday, January 3, 2023, the Parkway West Career and Technology Center approved the 2023-2024 General Operating and Jointure Budgets. The General Operating Budget totals **\$8,168,903** and the Jointure Budget totals **\$800,925**.

The Chartiers Valley School District contribution to the General Operating budget is an estimated **\$886,708.74**. The Chartiers Valley School District contribution to the Jointure budget is an estimated **\$69,553.61**.
