Transition Services Agreement 2020-2021 School Year**

Services will be available for purchase by Chartiers Valley School District from Goodwill of Southwestern Pennsylvania starting no earlier than September 14, 2020 and ending June 4, 2021.

Chartiers Valley School District will purchase Goodwill of Southwestern Pennsylvania's Transition WORKS! program services according to the following fee schedule:

Goodwill of Southwestern Pennsylvania reserves the right to request additional support, interrupt and/or terminate services in the event of disruptive behavior on the behalf of the program participant.

This Agreement specifies the roles and responsibilities of the Parties as they work in partnership to increase employment opportunities for persons with disabilities. The Parties of this Agreement agree to comply with all applicable state and federal laws, including but not limited to criminal background and child abuse clearances for all individuals having contact with students, as well as confidentiality requirements. Each party will indemnify and defend the other for any claims, damages, expenses or losses (including reasonable attorney fees) arising out of the acts or omissions of the indemnifying party, its employees and/or agents

1. Description of Services to be performed

Goodwill of Southwestern Pennsylvania will provide with a series of nine-week workforce readiness training rotations that include hands-on training, case notes, evaluations, follow-up meetings and other on-site programming needs at the assigned training site through Goodwill. Based on government mandate, services may be transferred to a virtual platform at any given time.

All services will occur weekly Monday – Friday between the hours of 8:30am and 2:00pm.

2. Goodwill agrees to:

- A. Provide support necessary to maximize success of the students.
- B. Attend any Team Meetings regarding students utilizing our services.
- C. Provide an evaluation of the student's progress at the end of each rotation.
- D. Invoice Chartiers Valley School District at the beginning of each rotation.

3. Chartiers Valley School District agrees to:

- A. Provide **complete and current** copies of the participants IEP's, medical information, school calendar, referral form, and transportation information **before** the participant begins Transition WORKS!
- B. Provide support necessary to maximize success of the students.
- C. Reimburse Goodwill for services billed within 30 days of receiving statement.
- D. Provide transportation to and from work site.
