On Tuesday, January 5, 2021, the Parkway West Career and Technology Center approved the 2021-22 General Operating and Jointure Budgets. The General Operating Budget totals **\$7,156,298** and the Jointure Budget totals **\$728,707**.

The Chartiers Valley School District contribution to the General Operating budget is an estimated **\$795,356.24**. The Chartiers Valley School District contribution to the Jointure budget is an estimated **\$76,203.52**.
