Dear Dr. Castagna:

On Tuesday, January 7, 2025, the Parkway West Career and Technology Center approved the 2025-2026 General Operating and Jointure Budgets. The General Operating Budget totals \$9,603,622 and the Jointure Budget totals \$1,079,716.

The Chartiers Valley School District contribution to the General Operating budget is an estimated \$1,007,727.42. The Chartiers Valley School District contribution to the Jointure budget is an estimated \$80,308.31.

You are asked to please place the budgets on your next Board agenda for approval. A copy of the agenda item must appear in your official Board minutes. To assist in this process, attached are:
